## BOCCE BALL COURT RENTAL

**LOCATION:** 1450 High Street (LINCOLN PARK)

**DAYS:** Monday, Wednesday, Thursday, Friday, Saturday, Sunday and Holidays: (No Tuesdays)

**HOURS:** 9:00 a.m. to half-hour after sunset.

### RESERVATIONS:

- **All requests** to be made in person, by fax, or by emailing ARPD, during regular business hours with a minimum of 7 business days in advance and a maximum of 6 months prior to your event. Contact ARPD for **availability** at above information.
- **Permits** are issued to adults 21 years and over.
- **Proof of residency** is required to obtain Alameda residency rates. This can be a utility bill.

### PERMITS:

- Facility Use Permit is available online at: [www.alamedaca.gov/recreation](http://www.alamedaca.gov/recreation). Submit with payment and proof of residency if applicable. **No changes** allowed to permit 7 business days prior to event.
- **No on-going permits issued** for a regular week-to-week or month-to-month basis.
- **Reservation signs are posted and permits checked.** Your space is only guaranteed for the paid times listed on your permit.

### CANCELLATIONS

- **Cancellations: Less than 7 business days to your event will forfeit all fees. More than 7 business days to your event a \$40 fee will be charged and the rest of the fees refunded.**
- **Rainy day policy:** Please advise our office on the first business day after your reservation if your picnic was cancelled due to rain and you will receive a credit on your ARPD account. No refunds.

### ALCOHOL:

Alcohol is only permitted inside the fenced area of the Bocce Ball Court and not allowed outside in the Park. You must obtain an alcohol permit through [www.cjprma.org](http://www.cjprma.org) and make sure the Recreation and Park Department has received your alcohol permit at least 7 business days prior to your event, otherwise no alcohol will be allowed.

### KEYS:

The Bocce Ball courts are locked. You will need to pick up and sign out for the key by 5:00 p.m. on Friday for a weekend reservation. If you are renting on a weekday, please pick up the key the day before by 5:00 p.m. At the end of your permit time, please lock the gate and return keys to the ARPD Office drop box, located on the left door at the end of your event.

### FEES:

RESIDENT	NON-RESIDENTS
\$12/hour with a 3-hour minimum on weekends	\$32/hour with a 3-hour minimum on weekends
\$12/hour with no hourly minimum on weekdays	\$32/hour with no hourly minimum on weekdays

\*All fees must be paid in full at the time the reservation is issued. VISA, Master Card, Discover Card, American Express, Cash or a personal check payable to ARPD are acceptable.

### THE FOLLOWING ARE NOT ALLOWED IN THE CITY OF ALAMEDA PARKS:

- **NO Smoking** in parks or within 20 feet of entrance or windows of buildings. (Ordinance #3038).
- **NO Personal Barbeques.** There are charcoal barbecue grills available for use at the picnics sites. Please leave charcoal in the public BBQ and ARPD staff will dispose of it.
- **NO Amplified Music, P.A. Systems or Use of Air Horns.**
- **NO** nails, tacks, staples, electrical tape or other marring materials are to be used on any City property.
