Please note:

- There are some picnic areas in our parks that remain first-come, first-served, however; outside
 vendors are not allowed at these picnic areas. You must have a picnic reservation to add a
 vendor/jumper.
- Charcoal barbecue grills are available for use at the picnics sites. Please leave charcoal in the public BBQ after use and the ARPD staff will dispose of it. No personal barbeques are allowed.

RESERVATIONS / PERMITS

- Availability and reservations: Picnic rentals are available on Saturdays and Sundays. Please call the Rental Office at 510-747-7576 to check availability. You may then submit a permit by email at arpd@alamedaca.gov, by fax, or in person during regular business hours. Your permit must be received at least 7 business days prior to event and may be submitted up to 3 months prior to your event. The Facility Use Permit, Picnic Policies and Park Information are available online at: www.alamedaca.gov/recreation under picnic rentals. Must be at least 21 years to obtain a permit.
- Three-hour minimum is required. Set-up and clean-up must be included in the requested hours.
- **No changes** allowed to the permit within 7 business days prior to event.
- No on-going permits issued for a regular week-to-week or month-to-month basis.
- **Reservation signs** are posted. Your space is only guaranteed for the paid times listed on your permit. For any issues the day of event, please call the Park Monitor at 510-775-5459 for assistance.
- Decorations must be removed at the end of the permit time. Please do not use Mylar balloons in parks. A single metallic balloon can cause a power outage when it makes contact with power lines. All helium balloons should be weighted to prevent them from floating away and becoming an environmental hazard.
- Large special events require a Special Use Permit: These include large organized events, such as a 5k Run, that impact a public right-of-way outside of the park. This may be obtained from the Community Development Dept., located at City Hall, 1st Floor. (510) 747- 6800. Please book your event with ARPD and the Special Use Permit is then required before the reservation is final.

DISCOUNTS

- City of Alameda Resident Discount A Utility Bill showing Proof of Residency and a picture I.D. is required to receive the discount.
- Active Military Discount Proof of active Military I.D. is required to receive the discount.

CANCELLATIONS

- Cancellations: Less than 7 business days to your event will forfeit all fees. More than 7 business days to your event, a \$40 fee will be charged and the rest of the fees refunded.
- Rainy day policy: Please advise our office on the first business day after your reservation if your picnic was cancelled due to rain and you will receive a credit on your ARPD account. No refunds.

VENDORS

The use of any outside vendors (inflatable jumpers, caterer, clowns, etc. by any rental groups must be approved by ARPD prior to date of use, and may include additional fees. Additional insurance requirements must be met seven (7) business days prior to date of event.

- NO Food trucks or automobiles allowed in the Parks.
- All dogs must be on leashes.
