(Public Works/ARPD): EXHIBIT 15-G must be submitted by all bidders. Exhibit 15-H however, and both Parts I and II of "Bidder's List of Subcontractors (DBE & Non-DBE)" can be submitted post-bid, no later than 5:00 pm, Monday, April 24th Wednesday, April 26th – by the lowest three responsive bidders.

B. CLARIFICATION TO ADDENDUM NO. 4 Item 12):

12) (**Public Works/ARPD**): All Bidders to submit with their bids a completed "Buy America Certification", per SECTION 13 - FEDERAL TRANSIT ADMINISTRATION CONTRACT CLAUSES. (See attached updated BID FORM CHECKLIST.)

Clarification: The applicable Certificate of Compliance in SECTION 13, for the Buy America Requirements, Project Manual pages 190, 191, are the items to be completed and submitted for this item.
