<u>City will furnish the chillers.</u> <u>Contractor to furnish Furnish all other</u> specified units and equipment shown in the project drawings and/or specified in the technical specification, Section Series 15600, 15050, 15080, and 15010 prior of dismantling/disabling of current system."

b. Section III. Scope of Work, Remedial Description, <u>Installation</u>, <u>Testing</u>, <u>Programming</u>, <u>Operating</u>, Page 21, and in Exhibit A Bidder's Proposal. The following paragraph is modified to read:

"Contractor will install City supplied chillers. Contractor shall provide and install all new pumps, chillers, piping components, water system balancing, control integration, initial water treatment, purging air handlers and priming, insulation and comply with all Specifications within Sections 15010, 15080, 15050, 15600, project drawings and manufacturer recommendations, etc. as indicated on the drawings for a complete and operating system. Caulk and seal using Sikaflex-1a polyurethane elastomeric sealant/adhesive, or approved equal.
